

Synopsis

The Consortium for Comparative Research on Regional Integration and Social Cohesion (RISC) will hold its first annual conference at the European Commission's headquarters in Luxembourg (Bâtiment Jean Monnet) from November 13-15, 2008.

This meeting will examine leadership and social cohesion politics cross-regionally in specific subject areas. Each of the panels is topically defined and each includes four presentations and a chair/discussant in order to promote comparative discussions of social cohesion issues.

The afternoon session on Friday November 14 will focus specifically on leadership. First, panel five will focus on social cohesion politics in Europe, North America, and South America with a specific focus on the events of 2008. It will examine the role of leadership in specific contexts related to these happenings.

Second, panel six will comparatively analyze styles of leadership and the impacts that they have on social cohesion. The papers presented in these panels will be published in 2009 as a book in the series entitled Regional Integration and Social Cohesion (Bruxelles: P.I.E./Peter Lang).

The remaining panels correspond to RISC's working groups (see www.risc.lu for full descriptions) and they have been organized by the groups' coordinators.

The conference will include presentations made in English, Spanish and French with simultaneous translation.
