Prof. Dr. Stéphane Rousseau



Stéphane Rousseau holds the Chair in Governance and Business Law and is full professor at the Faculty of Law of the Université de Montréal. He is the Director of the Center for the Law of Business and International Trade since 2008.

Professor Rousseau holds a Doctorate in Juridical Science from the University of Toronto and a master's degree in law from Université Laval. He is member of the Québec Bar. He specializes in corporate law, corporate governance, securities law, and law and economics. He is coauthor of three recent books: (with Raymonde Crête), *Droit des sociétés par actions*, 3e éd. (Éditions Thémis, 2011); (with Ejan Mackaay), *Analyse économique du droit*, 2e éd. (Dalloz/Éditions Thémis, 2008) et (with Patrick Desalliers), *Les devoirs des administrateurs lors d'une prise de contrôle - Étude comparative du droit du Delaware et du droit canadien* (Éditions Thémis, 2007). He is Visiting Professor at Université Paris I (Panthéon-Sorbonne) where he teaches Banking and Finance Law the Master's Programme.

Professor Rousseau has given conferences in academic and professional settings in Canada as well as abroad in numerous countries (Argentina, Australia, Brazil, China, France, United States, and Tunisia). He was awarded the André-Morel teaching excellence prize in 2007. In 2008-2009, Professor Rousseau was a member of the committee that advised the Quebec Minister of Finance on the reform of the Companies Act.
